- 'Borough never followed through with paving parking lot/repairs even though money was transferred to them for that purpose
- Ann- we paid them for terrible work totalling \$24k
- Board should ask KPD and DPW we need to know if you can help us- if not, we will hire our own security and clean up crew
 - No one said we have to use Borough employees for Borough events. It's a courtesy that the KBBC asks them to work
 - We need to know if they will work with us
 - Larry will invite them to the February KBBC meeting
- John spoke to Tom Arnone- maybe we can make some type of sign on the bridge structure to sway "Welcome to Keyport"

Jack Straub- complimented new Mayor hoping everyone can work together- asked for a return of the "pre meetings"

Ann- but what about fire department donation of \$5k (ended up being \$10k)

Open Public Session-

Jack Straub- explained how the BID gets money- it's a "special assessment"

John Merla

- we brought in the KBA in 1985 by changing from Chamber of Commerce
- Borough and KBBC are partners
- When he was Mayor there was a line item in the budget for \$20k for "celebration of public events"
- Reason why it was in municipal budget was to help the small organizations (fire department, libraries, clubs) instead of the KBBC paying for it
