- Page 8 I have included a proposed budget for fiscal year 2024. This does not include any surplus from fiscal year 2023. (Wait until JoAnne is back to discuss.)
- Page 10 Profit and Loss comparison 2022 to 2023
  - We have not received the assessments for the third and fourth quarter
  - o To date, we have spent 8K more in events than last year.
  - We reimbursed \$6,660 in Keyport Cash this year, up from \$3,520 from 2022.
  - This was the first year we went from tracking by individual events in the P&L to tracking seasonal events. We can still track per event, it just requires an additional report.
  - We spent less on events this year to date \$54,082 than year to date last year \$62,005.01
  - Administration cost remained similar 2023 \$34,934.36 / 2022 \$35,386.58
